Jamal Jahmarley Meyers did then and there unlawfully and feloniously, from a premeditated design to effect the death of human beings, to wit: Danny Colon and Gregory Lorenzo Campbell, and did kill said Danny Colon and Gregory Lorenzo Campbell, by shooting said victims with a firearm, contrary to F.S. 782.04(1)(a)1 and 775.087.

Probable Cause Affidavit

Before me this date personally appeared FARGNOLI, CARLO M. (1820) who being first duly sworn deposes and says that on 17 day of March, (year) 2022 at 1300 W BROWARD BLVD, FORT LAUDERDALE, FL 33312 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

attempted to effect the death of [REDACTED] and "John Doe", human beings, to kill [REDACTED] and "John Doe", and in furtherance of said attempt, did intentionally and unlawfully threaten by word or act to do violence to the person of [REDACTED] and "John Doe", coupled with an apparent ability to do so, and shot said victims, which created a well-founded fear in [REDACTED] and "John Doe" that violence was imminent, and said act was committed with a firearm, more particularly described as Semi-Automatic handgun, contrary to F.S. 777.04, F.S. 782.04(2) and F.S. 775.087.

Jamal Jahmarley Meyers having previously been convicted on 6/24/2021, under Case # 1701755CF10A, of the felony crime of Fleeing & Eluding a Law Enforcement Officer, Grand Theft Auto, Burglary of an Unoccupied Structure, in the Broward County Circuit Court, did then and there have in his care, custody, possession or control a firearm, to-wit: Semi-Auto Handgun, and during the commission thereof, Jamal Jahmarley Meyers actually possessed or carried that firearm on his person, contrary to F.S. 790.23(1) and F.S. 775.087(2) (a) 1.r.

On March 17th, 2022, at 3:25 PM, Fort Lauderdale Police Officer Daniel Hughes observed Broward County Transit Bus Number # 21005 proceeding westbound in the eastbound lane of traffic, and while doing so, struck two automobiles. Officer Hughes further reported that said Broward County Transit Bus# 21005 then drove into the parking lot of the Fort Lauderdale Police Department and came to a stop. Ofc. Hughes reported that he then heard three (3) gunshots and observed the defendant subsequently identified as Jamal Jahmarley Meyers quickly exit said bus. Ofc. Hughes then pointed his service weapon at Jamal Jahmarley Meyers and ordered him to lay in a prone position on the ground. Jamal

Probable Cause Affidavit

Before me this date personally appeared FARGNOLI, CARLO M. (1820) who being first duly sworn deposes and says that on 17 day of March (year) 2022 at 1380 W BROWARD BLVD, FORT LAUDERDALE, FL 33312 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Jahmarley Meyers was subsequently taken into custody without further incident.

Video surveillance from said Broward County Terminal Bus# 21005 depicted the bus proceeding westbound within the seven hundred block (700) of West Broward Blvd when Jamal Jahmarley Meyers withdraws a semi-automatic handgun from his right front pocket, and at 3:23:45 PM, fires twelve (12) rounds at the listed victims, who were seated in the rear of said bus. After firing twelve (12) rounds at said victims, Jamal Jahmarley Meyer reloaded his handgun and at 3:23:59 PM, fired an additional nine (9) rounds at the listed victims, shooting the final round at 3:24:48 PM.

Victim #1, Danny Colon, was transported to Broward General Medical Center and pronounced deceased at 4:08 PM from gunshot wounds.

Victim# 2, [REDACTED]

Victim# 3, Gregory Lorenzo Campbell, sustained multiple gunshot wounds to his body and was pronounced deceased on scene at 3:35pm.
