On 11-30-21, I began to investigate this retail theft that occurred on 11-26-21 at [REDACTED]. The following is a synopsis of the initial incident report written by Officer Schuss:

[REDACTED] reported several products missing from the store. A review of the store's surveillance video captured four black males, working in concert, stealing the reported products. The four males enter the store on 11-26-21 at 1431 hours described as follows:

Suspect #1- Black male, heavy set, 5'9-6'0, wearing a white shirt, black pants, brown rubber foam shoes with a tattoo sleeve on his left arm.
 Suspect #2- Black male, heavy set, 5'9-6'0, wearing a blue shirt (green writing "Life is Heavy"), black bandana on his head, blue mask, facial hair, and tattoo sleeve on both arms.
 Suspect #3- Black male 5'9-6'0, wearing a white tank top, blue sweatpants, red boxershorts, black mask, white slides, tattoos on both shoulders, two gold chains, one gold bracelet on his left wrist, and a black bandana on his head.
 Suspect #4- Black male, 5'9-6'0, short black dreads, wearing a red shirt, white pants, black/white slides, white mask, gold chain, and tattoo sleeves on both arms.

After entering the store, the suspects are captured walking to the accessories wall located on the right side of the store, where suspect #3 selected two 2nd Generation Apple Pencils (\$258.00). Suspect #3 concealed one Apple Pencil into the front of his pants and gave one Apple pencil to Suspect #4 who also concealed the Apple Pencil into the front of his pants.
 At approximately 1438 hours, Suspects #2, #3, and #4 walk together to the accessories wall located on the left side of the store. Suspect #2 selects four Apple Pencils (\$516.00), Suspect #3 selects three Apple Pencils (\$387.00), and Suspect #4 selects three Apple Pencils (\$387.00) from the shelf. All three suspects concealed the Apple

<p>Pencils they selected from the shelf by placing them into the front of their pants. At 1444 hours, Suspects #2, #3 and #4 then walk over to table #C1 and Suspect #3 takes one Apple AirPods Pros (\$249.00) and places it into the front of his pants. Suspects #2, #3 and #4 then exited the store via the front doors, passing all points of sale without paying for the concealed merchandise at approximately 1445 hours. Suspect #1 is also captured on video surveillance doing the following: Suspect #1 approaches a display table located in the middle of the store and grabbed an empty white Apple bag. Suspect #1 then walked to another display table, selected two Apple AirPods Pros (\$498.00), and concealed them into the empty Apple bag he was carrying. Suspect #1 then walked over to another display table and selected another Apple AirPods Pros (\$249.00) and placed it into the Apple bag. At approximately 1438 hours, Suspect #1 walks to the Express Table and waits for an Apple employee to walk away, leaving a bag of Apple AirPods Pros unattended (\$996.00). Suspect #1 took the unattended Apple bag / products. At approximately 1440hrs, Suspect #1 exits the store via the front doors, passing all points of sale without paying for the concealed merchandise.</p> <p>██████████ reported the following products stolen: eight (8) Apple AirPods Pros (\$249.00 / each) twelve (12) 2nd generation Apple Pencils (\$129.00 / each) TOTAL LOSS: \$3,540.</p> <p>██████████ provided Officer Schuss a recorded statement pertaining to this investigation. ██████████ advised Apple wishes to pursue charge(s) against the person(s) responsible.</p> <p>On 12-6-21, I met with Macys Loss Prevention and retrieved video from Macys. Their video captures the suspects exiting the north entrance/exit toward the parking lot. The suspect wearing the white shirt with "Duhlolean" exits Macys at 1442hrs carrying two white bags in his right hand which appear to have white boxes within. The other three suspects (red shirt, blue shirt, and white tank top) exit Macys at 1448hrs.</p> <p>A review of exterior parking lot camera(s) shows a vehicle, appearing to be a blue van, travel southbound in the parking lot toward the Macy's entrance and stop at the stop sign. Three of the suspects exit the Macys area and enter the van. It should be noted, the driver of the van appears to be wearing white, presumably the suspect who exited Macys prior to the other three suspects.</p> <p>Further intelligence gathering revealed a blue van (Michigan Tag: DVL8756) enter the Mall property at approximately 1422hrs on 11-26-21. The vehicle is a rental vehicle registered to EAN Holdings.</p> <p>Information was found that three subjects were arrested for a theft of electronics that occurred on 11-27-21 in Coral Springs (#21-9983). The synopsis of the investigation showed on 11-28-21, Coral Springs Police responded to the Best Buy (650 N. University) in reference to four B/M subjects inside the store matching the description of the theft</p>

<p> suspects from the day prior (#21-9983). Within the initial dispatch information, a van with the same Michigan license plate was associated with the call for service. Three of the suspects were detained and eventually arrested for the previous theft. </p> <p> A Broward booking photo(s) check of the three arrested subject`s from the Coral Springs investigation showed they resembled three of the suspects captured in this investigation. I contacted the Coral Springs Police Department and later spoke with Officer Pearce (#1094) who conducted the above Coral Springs investigation and arrested the subjects. </p> <p> On 12-9-21, I e-mailed a clerked subpoena to EAN Holdings representatives requesting the vehicle renter information and associated information. I later received information that the vehicle was rented by a Tsiyah Cook (7-19-97) out of 67 Hill St, Statent Island, NY (NY DL- 591179757) under reservation number #0013477408895 / Expedia). The reservation was made on 11-26-21 at 0015hrs and picked up at 0034hrs. It should be noted, Cook was one of the suspects arrested by Coral Springs Police Department on 11-28-21. </p> <p> On 12-9-21, I met with [REDACTED] regarding this investigation. [REDACTED] copied the store`s video surveillance in a different format to assist in identifying the concealments and included the time stamps for reference. [REDACTED] completed a Victims` Right to Confidentiality Form. </p> <p> Once Officer Pearce returned to work, I sent him the still images of the four suspects exiting Macys on 11-26-21. Officer Pearce confirmed three out of the four suspects pictured are the same he arrested on 11-29-21 in Coral Springs. Officer Pearce identified three of the suspects exiting the Boca Raton Macys as follows: </p> <div style="background-color: black; height: 80px; width: 100%; margin: 5px 0;"></div> <p> Tsiyah Nasir Cook (7-19-97) CLOTHING: black cap, gold chains, under shirt, light blue sweat pants, and sandals NY DL: 591179757 </p> <p> The fourth suspect pictured exiting Macys wearing a white shirt with "Duhlolean" was not identified. </p> <p> Officer Pearce also sent me photos of the suspects when they were arrested in Coral Springs. [REDACTED] appears to be wearing the same red shirt with the insignia on the front as captured in this Boca Raton incident. [REDACTED] tattoos also resemble the suspect </p>

[REDACTED] appears to have the same tattoos and facial/head hair style as the suspect captured in the Boca Raton incident. When detained by Coral Springs Police, a black durag was captured on the curb next to wear [REDACTED] was pictured. This durag resembles the durag worn by the suspect in Boca Raton.

A RAPID/LEADS search of the three identified suspects revealed no investigative leads.

After conducting this investigation, probable cause was developed for [REDACTED] and B/M Tsi ah Cool for violating the following FSS:

Theft in concert with others over \$3,000 - 812.014 (6)

This investigation will be forwarded to the Palm Beach County State Attorneys Office requesting a warrant be issued for the suspects.
